
Dear System User,

In these hot summer days, we are glad to bring you some fresh news from TAG GmbH's Commercial Department: some updates regarding the integration with PRISMA, secondary assignment process, the publication of an e-tender for the purchase of fuel gas, as well as an update of the scheduled maintenance works. ## 1. <u>Transition period for PRISMA integration & 4<sup>th</sup> training session for TAG Shippers</u>

The new commercial services module, hosted on the PRISMA platform will be rolled-out on September 28<sup>th</sup>. A few hours later, the new functionalities will be available for the system users of the TAG system.

In preparation of this event, key information and contractual data will be progressively migrated, while a few functionalities will be step-by-step reorganized, to ensure a smooth transition. System users, whenever possible, are invited to anticipate the necessary adjustments to their commercial data and setups, according to the plan shown below. The Customer Success Team of PRISMA and the Commercial Department of TAG will support in case additional effort is needed.

# 2. <u>Adjustment of the secondary assignment information: regulated tariff & parent</u> <u>transaction</u>

In order to progressively integrate the commercial historical database of TAG into the PRISMA system, assignments performed on the secondary market needs to be linked to existing transactions:

- a. Primary Deals Concluded on PRISMA
- b. Secondary Deals Concluded on PRISMA (e.g. assignment of LT contracts)
- c. Contracts concluded outside of the platform (e.g. LT contracts)

This setting can be selected while creating the trade proposal (sell) or responding to a trade proposal (buy).

For Long Term contracts in particular, it is necessary to enter the correct combination of elements to make the trade proposal valid.

Please contact the Commercial Team of TAG for further support, in case your company is planning to perform assignments in the coming weeks! In particular, due to the introduction of the additional functionalities in PRISMA, longer elaboration times may be necessary.

The e-Tender purchase event will take place from 10.08.2022, 11:00 a.m. until 11.08.2022, 11:30 a.m. and it will be executed by means of the TAG e-Procurement Platform.
