1. SUCCESSFUL DEVELOPMENT OF FALL-BACK PLATFORM

As of now, in case of temporary **unavailability of the PRISMA Capacity Platform**, TAG GmbH provides an internet <u>Fall-Back platform</u> "TAG GmbH's Fall-back Platform", where primary Day-ahead and Within-day unbundled entry and exit capacities of the TAG system are marketed.

In order to access this platform, PRISMA activated users will receive **one-time password** sent by e-mail upon activation of the platform and valid until deactivation of the Fall-back platform.

2. SINGLE REGISTRATION FOR AUCTIONS, NO PROVISION OF TEMPORARY DEPOSIT & NEXT COMMERCIAL DEVELOPMENT STEPS

In order to smoothen the processes for System Users, TAG GmbH is going to simplify the procedure of registration for Monthly/Quarterly/Yearly auctions as of **12.07.2019**, until further notice. The registration for these products will have to be performed by System User **once** with **unlimited validity**. Furthermore, the provision of a **temporary** deposit will **not be** requested any longer.

Further to some System User's requests, the **Maintenance** Plan of scheduled maintenance activities of TAG GmbH has been made available also in **Excel** format.
