1. NEW TARIFF APPLICATION AS OF 01.01.2021

Pursuant to the new <u>Gas System Charges Ordinance</u> published by the Austrian National Regulation Authority, the transportation tariffs to be applied will undergo a variation as 01.01.2021. Kindly find hereby a recap of the new most relevant tariffs for TAG's system users:

Baumgarten Entry 0,85 €/kWh/h/year

Arnoldstein Exit 4,35 €/kWh/h/year

Arnoldstein Entry: 0,68 €/kWh/h/year

Multipliers for products with duration <1 year:

- Quarterly 1,15
- Monthly 1,3
- Daily 1,5
- Within-Day 2

2. MAINTENANCE PLAN 2021

3. ENHANCED REPORTING OF ASSIGNED CAPACITIES IN CODIP WEBNOMINATION PLATFORM

UP TO NOW. Using the CoDiP 24/7 web nomination platform for submitting day-ahead and intra-day (re) nominations the Balance Responsible Party (user) could find an overview in the nomination tracking showing the inserted + uploaded nominations and the status + results of the nomination processing. The available capacity assigned to the respective Balance Group was only reported after the processing of the nomination as a result of the internal capacity check.

NEW. Since the latest update of CoDiP, the assigned capacity for a Balance Group is already available as pre-processing information. That means that the assigned capacity is displayed in the hourly overview of the Nomination Tracking and can be compared immediately with the submitted nomination before the end of the reception phase. This provides the Balance Responsible Party with the opportunity to compare the assigned capacities with the respective nominations much earlier in the nomination process and - if needed - to adjust the level of available capacities by assigning additional quantities.
